In exercise of the powers conferred by Section 93 (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation & Resettlement Act, 2013, the State Government do hereby withdraw entire land measuring to Ac.0.29 dec. as per the land schedule given below in village-**Karanjakoili** , P.S-Betnoti No. 107, Tahasil- Betnoti, District- Mayurbhanj covered by Revenue & DM Department Notification No. 26920 dated 10.09.2019 published in the extraordinary issue of the Odisha Gazette No.2249 dated 16.12.2019 and Declaration No. 24886 dated 19.08.2020 acquired for construction of Muktapur Sub-Minor under Subarnarekha Irrigation Project of which possession has not been taken.


