Whereas, under para (i) of the proviso to clause 1 of Schedule V-A of the Odisha Government Land Settlement Rules, 1983, for settlement of land, applications were required to be submitted within a period of six months from the date of publication of the Odisha Government Land Settlement (Amendment) Rules, 2014; or within such further period as may be appointed by notification published in the Official Gazette from time to time.

And, whereas, the period of limitation was extended from time to time and the last such extension has been made in the notification of the Government of Odisha in the Revenue & Disaster Management Department No. 24960-RDM-LRGEA-STATUT-0005/2018, dated the 22nd August, 2019 published in the Extraordinary issue of the Odisha Gazette No. 1645, dated the 22nd August, 2019;

And, whereas, the period of limitation last extended has expired on the 1st April 2020;

And, whereas, it has come to notice that a number of applicants are still awaiting to apply for settlement of the land of the categories mentioned in sub-clauses (a) and (b) of clause 1 of Schedule V-A of the Odisha Government Land Settlement Rules, 1983;

And, whereas, unless the time limit is extended, a number of applicants shall be debarred from getting such land settled with heritable and transferable rights;

And, whereas, the State Government are satisfied that there exists sufficient reasons for extending the said period of limitation;

Now, therefore, in exercise of the powers conferred by para (i) of the proviso to clause 1 of Schedule V-A of the Odisha Government Land Settlement Rules, 1983, the State Government do hereby further extend the said period upto 31.03.2022.
