

NOTIFICATION

In exercise of powers conferred under sub Section-1 of Section 3 of the Odisha Special Survey and Settlement Act, 2012 read with Sub-Rule-1 of Rule 4 of Odisha Special Survey and Settlement Rules-2012 (Odisha Act 5 of 2012), the State Govt. do hereby notify 19 number of villages of Jahrsuguda District as at Schedule for conduct of Special Survey and Settlement and preparation of Record of Rights simultaneously with respect to all lands lying in the areas comprised within the limits of villages.

The settlement of rent with respect to above said areas shall be determined as per the prevailing guidelines issued by Revenue & Disaster Management Department.
