Whereas the preliminary notification under section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 was issued by Government for acquisition of private land measuring an area of land measuring Ac. 5.572 in village- Ichhadeipur, under Dhenkanal Tahasil for construction of Salegan-Budhapanka-Talcher-Jharpara 3rd and 4th line Rail Link project vide Collector Dhenkanal Notification No. 110 dated 04.05.2018 and Declaration U/s-19(1) of the Act was issued vide Collectorate, Dhenkanal Declaration No. 139 dtd. 01.05.2019 which was published in the Extraordinary issue of Odisha Gazette No. 995 dtd. 13.06.2019 however passing of award under section 23 of the Act in respect of the above schedule of land has not been issued till date;

And whereas, as per section 25 of the Act, the Collector shall make an award within a period of twelve months from the date of publication of the declaration under section 19 and if no award is made within that period, the entire proceedings for the acquisition of the land shall lapse. The first proviso to section-25 of the Act provides that the appropriate Government shall have the power to extend the period of twelve months if in its opinion, circumstances exists justifying the same. The second proviso to section-25 of the Act provides further that any such decision to extend the period shall be recorded in writing and the same shall be notified and be uploaded on the website of the authority concerned;

And whereas, the Department of Commerce & Transport (Transport) Department has requested vide their letter No. 8078 dtd. 15.09.2021 to extend the period of twelve months and the appropriate Government is of the opinion that circumstances existed for the inadvertent delay;

Now, therefore, in exercise of the powers conferred under First proviso of section 25 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (30 of 2013), the State Government do hereby decide to extend the period of validity up to 31st December 2021 for passing of award under section 23 of the said Act.
