Sub: Timeline for providing caste particulars in investigation booked under SC&ST (PoA) Act

Madam/ Sir,

In inviting reference to the above mentioned subject, I am to say that inordinate delay has been reported in connection with furnishing caste particulars of complainants as well as victims in investigation cases booked under SC & ST(PoA) Act. It is pertinent to mention here that Caste certificates have been mandated to be issued within 15 days by the Designated Officers (Tahasildars/ Addl. Tahasildars) under ORTPS Act, 2012 vide Gazette Notification No.17890 dt.20/07/2021

Therefore, caste particulars (SC/ST) of complainants as well as victims by the Tahasildars/ Addl. Tahasildars shall be furnished by the Tahasildars/ Addl. Tahasildars within this stipulated period of 15 days in connection with investigation cases under SC/ST (PoA) Act. Necessary instructions may be issued to the field functionaries concerned.

You are therefore requested to instruct your field officials under your jurisdiction to adhere to the above said timeline without any deviation.




