NOTIFICATION

In partial modification of this Department Notification No. 29216 dated 23.09.2021 read with Corrigendum No.11911 Dated 18.04.2022, Notification No. 21899 dated 07.05.2012, Notification No.20493 dated 15.07.2015 and in exercise of the powers conferred by Clause(h) of Section 2 of the Odisha Consolidation of Holding and Prevention of Fragmentation of Land Act,1972 (Odisha Act 21 of 1972), the State Government do hereby notify that the officers mentioned in Column (2) of the Table given below will exercise the revisional powers of the Consolidation Commissioner under the said Act and Rules made there under in respect of such areas as noted against each in Column (3) thereof for the purpose of early disposal of the revisional cases.
