
WITHDRAWAL NOTIFICATION

In exercise of the powers conferred by Section 93 (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation & Resettlement Act, 2013, the State Government do hereby withdraw an area of Ac. 0.32 out of the notified area of Ac.4.32 as per the land schedule attached herewith from acquisition of land in village- **Kochiasul** , P.S.- Baisinga No. 181 , Tahasil- Rasagobindapur, Dist.- Mayurbhanj covered by Revenue & DM Department Notification No. 30177 dated 01.10.2021 published in the extraordinary issue of the Odisha Gazette No. 2024 dated 07.12.2021 for construction of Karanjapada and Baincha Minor under Subarnarekha Irrigation project of which possession has not been taken.


