

No. PT1-RDM-census-CENSUS-0001-2019: 734 /R&DM, In exercise of the powers conferred under clause (iv) of rule 8 of the Census Rules, 1990, and in partial modification of this Department Notification No.25187/R&DM, dated 21.08.2020, No.5513/R&DM, dated 17.02.2021, No.14039/R&DM, dated 28.04.2021 and No. 21657/R&DM dated 27.07.2021, the State Government do hereby allow changes of administrative boundaries of the Districts, Sub-Divisions, Tahasils, Revenue Villages and also Urban Local Bodies so fixed including boundaries fixed under any law for the time being in force, before 30<sup>th</sup> June, 2022. The boundaries of administrative units for ensuing Census will be frozen on 30<sup>th</sup> June, 2022.


