In exercise of powers conferred under clause (g) of Section 3 of Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation & Resettlement Act. 2013, the State Government do hereby designate **Sri Narayan Mishra, OAS-1(JB), Deputy Collector, Rayagada** as Special Land Acquisition Officer, Titilagarh-Vizianagaram 3rd line Railway Project, in respect of Rayagada District under the said Act & to perform the functions of LA Collector for acquisition of private land in addition to his own duties from the date of joining in the post until further orders.

Earlier Notification No.18985 dated 02.07.2021 designating Sri Munindra Honnaga, OAS-1(JB) as Special Land Acquisition Officer in respect of Rayagada District for the aforementioned project is modified accordingly. Sri Munindra Honnaga will continue to perform as Special Land Acquisition Officer in respect of rest of the Project excluding Rayagada.
