NO. RDM-LAC-JHS-0003-2020/ 24643 R&DM, DATED 25 JUL 2022

Whereas the preliminary notification under section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 was issued by Government for acquisition of private land measuring an area of Ac.233.99 in village-Tareikela under Jharasuguda Tahasil of Jharsuguda District vide Collectorate, Jharsuguda Notification No.16176 dated 05.10.2020 which was published in the Extraordinary issue of Odisha Gazette No. 1606 dated 28.12.2020 and the validity period was extended upto 30.06.2022 vide Revenue & DM Department Notification No.39583 dated 29.12.2021 and Declaration under section 19(1) of the Act in respect of the above village has not been issued till date;

And whereas, as per sub-section (7) of section 19 of the Act, where no declaration is made under subsection (1) of section 19 within twelve months from the date of preliminary notification, then such notification shall be deemed to have been rescinded and the second proviso to subsection (7) of section 19 provides that the appropriate Government shall have the power to extend the period of twelve months, if in its opinion circumstances exist justifying the same;

And whereas, Addl. District Magistrate(Rev.), Jharsuguda has requested with reasons to extend the period of validity and the appropriate Government is of the opinion that circumstances existed for the inadvertent delay;

Now, therefore, in exercise of the powers conferred by second proviso to sub-section (7) of section 19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (30 of 2013), the State Government do hereby decide to extend the period of validity upto **30.12.2022** for issue of Declaration under section 19(1) of the said Act.
