
WITHDRAWAL NOTIFICATION

No RDM-LAA-CTC-0005-2015 29948 /R&DM, dated 09 SEP 2022

In exercise of the powers conferred by Section 93 (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation & Resettlement Act, 2013, the State Government do hereby withdraw land measuring to **Ac.15.530 dec.** out of the Notified area covered by Revenue & DM Department Notification u/s 4(1) vide No. 29794 dated 11.07.2008 and Declaration u/s 6(1) vide No.28793 dated 21.07.2009 of LA Act, 1894 published in the extraordinary issue of the Odisha Gazette No. 1461 dated 02.08.2008 and No. 1102 dated 30.07.2009 respectively acquired for Industrial Projects by IDCO in village-Rahangol, P.S- Gurudijhatia, Tahasil-Athgarh, District-Cuttack of which possession has not been taken.
