Whereas the preliminary notification under section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 was issued by Revenue & DM Department for acquisition of private land measuring an area of Ac.14.302 dec for village-Raghunathprasad (Addl.), P.S./Tahasil-Tangi Choudwar, Dist.- Cuttack coming under acquisition for construction of Darpani Branch Canal under RRCS, Dhenkanal vide R & DM Notification No.6508 dated 23.02.2019 which was published in the Extraordinary issue of Odisha Gazette 803 on dated 23.04.2019 and Declaration under section 19(1) of the Act in respect of the above schedule of land has not been issued till date;

And whereas, as per sub-section (7) of section 19 of the Act, where no declaration is made under subsection (1) of section 19 within twelve months from the date of preliminary notification, then such notification shall be deemed to have been rescinded. The second proviso to subsection (7) of section 19 provides that the appropriate Government shall have the power to extend the period of twelve months, if in its opinion circumstances exist justifying the same;

And whereas, the Administrative Department has requested with reasons to extend the period of twelve months and the appropriate Government is of the opinion that circumstances existed for the inadvertent delay.

Further, as per 2nd proviso to sub-section(7) of section 19 of RFCTLAR&R Act, 2013, the statuotary period of 12 months had been extended up to 31.03.2021 vide R & DM Letter No. 3030 dated 28.01.2021.

Now, therefore, in exercise of the powers conferred by second proviso to sub-section (7) of section 19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (30 of 2013), the State Government do hereby decide to further extend the period of twelve months from the date of Preliminary Notification u/s 11(1) of the RFCTLAR&R Act, 2013 up to 30<sup>th</sup> November, 2022 for issue of Declaration under section 19(1) of the said Act.
