No. RDM-CON-PM- 0064-2019 17225 /R&DM, In pursuance of Odisha Administrative Services (Method of Recruitment and Conditions of Service) Rules, 2011, the State Government do hereby appoint the following 36 (thirty six) candidates who have come out successful in Odisha Civil Services Examination, 2017 conducted by Odisha Public Service Commission, Cuttack to Odisha Administrative Service, Group-A (Junior Branch) in Cell-1, Level-12 of the pay matrix under Odisha Revised Scale of Pay Rules, 2017.

They shall be on probation for a period of two years and their appointment is subject to verification of antecedents, medical fitness and verification of original certificates in cases where it has not been done. On receipt of adverse report on character and antecedents, his / her services shall be terminated forthwith in accordance with the provisions laid down in sub-clause (ii) of clause (h) of Explanation under Rule-13 of the Odisha Civil Services (Classification, Control and Appeal) Rules, 1962, reinforced in G. A. Department Resolution No.34438/ Gen., dated 20.11.1999.

On being appointed to OAS Group-A (JB), the candidates are hereby posted as Training Reserve Officers in the districts mentioned against each.

The candidates are instructed to join in the respective District Offices (Office of the Collector & District Magistrate) within 15 days from the date of issue of this appointment order.
