Whereas the SIA Notification under section 4(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 was issued by Government for acquisition of private land measuring an area of Ac. 732.335 in 20 nos. villages under Jeypore & Borigumma Tahasils of Koraput District for construction of Jeypore-Nabarangpur New B.G. Rail Project vide Revenue and DM Department SIA Notification No. 18771 dated 05.06.2020 & SIA Declaration No.33102 dated 03.11.2021 and Preliminary Notification under section 11(1) of the Act in respect of the above schedule of land has not been issued till date;

And whereas, as per section 14 of the Act, where a preliminary notification under section 11 is not issued within twelve months from the date of appraisal of the Social Impact Assessment report submitted by the Expert Group under section 7, then, such report shall be deemed to have lapsed and a fresh Social Impact Assessment shall be required to be undertaken prior to acquisition proceedings under section 11. The first proviso to section 14 provides that the appropriate Government shall have the power to extend the period of twelve months, if in its opinion circumstances exist justifying the same;

And whereas, due to frequent Lockdown and shutdown declared for Covid-19 pandemic, has affected the normal work in the field and Government of Odisha has declared force majeure for a period of 373 days vide Notification No.2765 dated 25.01.2021 and No.27574 dated. 13.09.2021.


Now, therefore, in exercise of the powers conferred by first proviso to section 14 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (30 of 2013), the State Government do hereby feel that circumstances existed Justifying the delay in issue of preliminary Notification and hence decide to extend the period of validity for issue of preliminary Notification U/s-11(1) of the RFCTLAR&R Act, 2013 up to **28th July 2023**.


