In exercise of the powers conferred by sub-clause (ii) of clause (b-1) of section 2 of the Odisha Government Land Settlement Act, 1962 (Odisha Act 33 of 1962) and in supersession of the notification of the Government of Odisha in the Revenue and Disaster Management Department No. 30897- RDM-LRGEA-STATUT-0007/2018/R&DM, dated the 21st August, 2018, published in the Extra - ordinary issue of the Odisha Gazette No. 1539, dated the 23rd August, 2018, the State Government do hereby specify Rs.1,00,000/- (Rupees One lakh) only as the ceiling of annual income of landless agricultural labourer as defined in the said clause.


