

In exercise of the powers conferred by clause (a-2) of section 3 of the Odisha Prevention of Land Encroachment Act, 1972 (Odisha Act 6 of 1972) and in supersession of the notification of the Government of Odisha in the Revenue and Disaster Management Department No. 30918- RDM-LRGEA-STATUT-0007/2018/R&DM, dated the 21st August, 2018, published in the Extra - ordinary issue of the Odisha Gazette No. 1542, dated the 23rd August, 2018, the State Government do hereby specify Rs.1,00,000/- (Rupees One lakh) only as the ceiling of annual income of homesteadless person as defined in the said clause.
