ORDER

In consideration of the proposal of Collector, Bhadrak for creation of a Special Land Acquisition Cell in Bhadrak District in order to expedite timely completion of the Land Acquisition and RR Process of more than 1000 acres of land for Industrial Park and Textile Park, the Government have been pleased to approve the proposal to set up a Special Land Acquisition Cell in Bhadrak District with following staffing pattern.

The Special Land Acquisition Cell in Bhadrak District shall function with the following stipulations.


1. The expenditure towards functioning of the Special LA Cell shall be incurred as per the guidelines relating to accounting procedure rules for land acquisition contingencies issued by this Department from time to time.
2. Collector, Bhadrak shall take steps for engagement of Non-Gazetted staff as per the yardstick on locating surplus staff in Tahasils or other Offices under the administrative control of the Collector, Bhadrak or engage retired govt. employees on contractual basis as per the guidelines of GA & PG Department and Finance Department to this effect issued from time to time and the cost towards salary component of the Non-Gazetted supporting staff and their expenditures shall be borne by Industries Department/ concerned industries.
3. The OAS & ORS Officers are to be deployed by the Revenue & DM Department / GA & PG Department out of the earmarked posts of District Administration and their salary shall be borne by the respective Departments. Besides, if the required Government officials are not available, the Gazetted Officers can also be filled in by retired officers as per the relevant guidelines of GA & PG Department and Finance Department issued from time to time and the cost to be borne by the **Industries Department/ concerned industries.**
4. Considering the extent of land to be acquired for different Industrial Projects in Bhadrak District, subsequent revision of the strength of Gazetted Officers and Non-Gazetted Staff for the Special Land Acquisition Cell at Bhadrak, if required, may be done by Government on recommendation of Collector, Bhadrak as per the yardstick

enumerated in the erstwhile Revenue & Excise Department letter No.29128/Dt.06.05.1964.

5. D.E.Os are not to be engaged for the functioning of the special land acquisition cell at Bhadrak since recently Government have decided that henceforth no Data Entry Operators shall be engaged on a contractual/outsourced basis in any Department of Government/ Heads of Departments and subordinates offices as per letter No. 23582 dated 13.07.2022 of Home Department. The work of DEOs are to be managed by the computer knowing Senior/Junior Revenue Assistant.


