No. PT1-RDM-CON-PM-0266-2022- 11842 /R&DM, In pursuance of Rule-4(a)(ii) of Odisha Administrative Service (Method of Recruitment and Conditions of Service) Rules, 2011 and pending concurrence of Odisha Public Service Commission, the following ORS, Group-B officers are hereby appointed to OAS, Group-A(JB) on ad-hoc basis in Level-12 of the Pay Matrix of ORSP Rules, 2017 on promotion against the Recruitment Year, 2023 for a period not exceeding one year or till receipt of recommendation of Odisha Public Service Commission or till their retirement, whichever is earlier without prejudice to the claim of others.




