NOTIFICATION

No. RDM-LRGEA-STATUT-0001-2023 - 13135

Whereas, under para (i) of the proviso to clause 1 of Schedule V-A of the Odisha Government Land Settlement Rules, 1983, for settlement of land, applications were required to be submitted within a period of six months from the date of publication of the Odisha Government Land Settlement (Amendment) Rules, 2022 issued under the notification of the Government of Odisha in the Revenue and Disaster Management Department No. 13970-RDM-LRGEA-STATUT-0001/2021/R&DM, dated the 2nd May, 2022 published in the Extra-ordinary issue of the Odisha Gazette No. 1588, dated the 4th May, 2022;

And, whereas, the period of limitation so provided have expired on the 4th November, 2022;


And, whereas, it has come to notice that a number of applicants are still awaiting to apply for settlement of the land of the categories mentioned in sub-clauses (a) and (b) of clause 1 of Schedule V-A of the Odisha Government Land Settlement Rules, 1983;

And, whereas, unless the time limit is extended, a number of applicants shall be debarred from getting such land settled with heritable and transferable rights;

And, whereas, the State Government are satisfied that there exists sufficient reasons for extending the said period of limitation;

Now, therefore, in exercise of the powers conferred by para (i) of the proviso to clause 1 of Schedule V-A of the Odisha Government Land Settlement Rules, 1983, the State Government do hereby extend the said period upto 31.10.2023.
