NOTIFICATION

In exercise of powers conferred under sub Section-1 of Section 3 of the Odisha Special Survey and Settlement Act, 2012 read with Sub-Rule 1 of Rule 4 of Odisha Special Survey and Settlement Rules-2012 (Odisha Act 5 of 2012), the State Govt. do hereby notify to carry out Special Survey and Settlement and preparation of Record of Rights in respect of the accreted land of approx. Ac 232.90 on the south east side of **Revenue Village- Badaputi(ବଡ଼ପୁଟି) Thana-Chamakhandi Thana No. 58 Tahasil-Chhatrapur Dist-Ganjam.**

The proposed Boundary line of the accreted area to be surveyed is as follows:

East: Bay of Bengal

West: Bay of Bengal

North: Mouza Badaputi Plot No.862, 863

South: Bay of Bengal

The settlement of rent with respect to above said areas shall be determined as per the prevailing guidelines issued by Revenue & Disaster Management Department.

The entire patch of accreted land shall be recorded in one plot in Abada Jogya Anabadi (AJA) Khata of the village Badaputi and a separate sheet of map may be prepared for the accreted land.
