NOTIFICATION

On the recommendation of the Odisha Public Service Commission (OPSC), Cuttack vide their letter No.2935/PSC dtd.20.03.2023, No.4635/PSC dtd.29.05.2023 and No. 4954/PSC dtd.12.06.2023, the following 39 (Thirty Nine) numbers of candidates are hereby appointed as Post Graduate Teachers (PGTs) under Science streams in the rank of Group-B Cadre under Odisha Higher Secondary Education Service (in State's Scale of Pay) (Method of Recruitment and Condition of Service of Post Graduate Teachers of the Scheduled Tribe & Scheduled Caste Development Department) Rules-2016 in the scale of pay of Rs.44,900/-in level-10 of Cell-1 of pay matrix of ORSP Rule-2016 (as per 7th Pay Commission) and other allowances as admissible and sanctioned by Government from time to time.

1. The appointment is purely temporary and terminable at any time without prior notice and without assigning any reason thereof.
