
NOTIFICATION

Whereas, the State Government are satisfied that there exist sufficient reasons for extending the period of limitation provided under Para (ii) of the Revenue and Disaster Management Department Notification No. 33446/R&DM, dated 05.08.2011 in the matter of freezing of settlement of Government land in 556 villages coming within the jurisdiction of Bhubaneswar Development Authority;
