No. RDM-Reg-REGN-0145-2019-33026 / R&DM, In exercise of the power conferred by sub-section (1) of the section 5 of the Registration Act. 1908 (16 of 1908), and in partial modification of the Notification of the Government of Odisha in erstwhile Revenue and Excise Department No. 705/Regn. dated the 24th April, 1964, the State Government do hereby direct that the Revenue Villages as specified in the schedule below, which have hitherto been included in the local limits of Registration Sub-District of Khalikote in the Registration District of Ganjam, as the case may be, shall, with effect from the date of publication of this Notification in the Extra-Ordinary issue of the Odisha Gazette, cease to have been so included and from the said date, the said villages shall form a part of the Registration Sub-District of Kodala.




