Whereas the preliminary notification under section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 was issued by the Collector, Khordha for acquisition of private land measuring an area of Ac. 1.961 dec in Mouza- Jayadev Vihar, P.S.- New Capital, Tahasil-Bhubaneswar, Dist.- Khordha for improvement of Master Plan Road from Institute of Mathematics to Ekamrakanan via Infocity vide Office of the Collector, Khordha Notification No.14463 dated 21.09.2020 which was published in the Extraordinary issue of Odisha Gazette 1193 on dated 28.09.2020 and Declaration under section 19(1) of the Act in respect of the above schedule of land has not been issued till date;

And whereas, as per sub-section (7) of section 19 of the Act, where no declaration is made under subsection (1) of section 19 within twelve months from the date of preliminary notification, then such notification shall be deemed to have been rescinded. The second proviso to subsection (7) of section 19 provides that the appropriate Government shall have the power to extend the period of twelve months, if in its opinion circumstances exist justifying the same;

And whereas, in exercise of the powers conferred by second proviso to sub-section (7) of section 19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (30 of 2013), the State Government vide its Letter No.10193/R&D.M.,dated 18.03.2023, had extended the period of twelve months from the date of Preliminary Notification u/s 11(1) of the RFCTLAR&R Act, 2013 up to **31st August, 2023** for issue of Declaration under section 19(1) of the said Act.

And whereas, the Collector, Khordha has requested with reasons to grant a second extension after the lapse of the time limit on **31st August, 2023** and the appropriate Government is of the opinion that circumstances existed for the inadvertent delay.



Now, therefore, in exercise of the powers conferred by second proviso to sub-section (7) of section 19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (30 of 2013), the State Government do hereby decide to further extend the period of twelve months from the date of Preliminary Notification u/s 11(1) of the RFCTLAR&R Act, 2013 up to **29th February, 2024** for issue of Declaration under section 19(1) of the said Act.
