In exercise of the powers conferred by section 27 of the Odisha Special Survey and Settlement Act, 2012 ( Odisha Act 5 of 2012), the State Government do hereby make the following rules, further to amend the Odisha Special Survey and Settlement Rules, 2012, namely: —

1. (1) These rules may be called the Odisha Special Survey and Settlement (Amendment) Rules, 2023.

(2) They shall come into force on the date of their publication in the Odisha Gazette.


2. In the Odisha Special Survey and Settlement Rules, 2012 (hereinafter referred to as the said rules), in rule 9, in sub-rule (7), for the letter and the words “for a period of fifteen days” the letter and words “for a period ten days” shall be substituted.

3. In the said rules, in rule 10, in sub-rule (3), for the letter and the words “within a maximum period of thirty working days”, the letter and the words “within a maximum period of fifteen working days” shall be substituted.

4. In the said rules, in rule 12, in sub-rule (1), for the letter and the words “for a period of thirty days”, the letter and the words “for a period of fifteen days” shall be substituted.

5. In the said rules, in rule 13, in sub-rule (10), for the letter and the words “a maximum period of sixty days”, the letter and the words “a maximum period of thirty days” shall be substituted.


