ORDER

Whereas, on the basis of the report of the Commission of Inquiry headed by Hon'ble Justice Shri Bimal Prasad Das, Retired Judge of Orissa High Court for better administration and governance of Shree Jagannath Temple and its endowments and the safety and security of the Temple and the devotees, Government of Odisha have taken up several projects under the Augmentation of Basic Amenities and Development of Heritage and Architecture (ABADHA) Scheme in Puri town. Lands are being acquired/ purchased under the provisions of RFCTLAR&R Act, 2013.

And whereas, in order to streamline and expedite the process, Government vide order No. 38690 dated 05.12.2019 published in EOG Vide No. 2220 dated 07.12.2019 had been pleased to set up a Special Land Acquisition Cell in Collectorate, Puri for two years or till completion of Land Acquisition process in Puri under the ABADHA Scheme whichever is earlier with the staffing pattern and the condition of their engagement enumerated therein.

And whereas, Government vide order No. 35369 dated 24.11.2021 published in EOG Vide No. 1960 dated 25.11.2021 had been pleased to extend the time period for functioning of Special Land Acquisition cell, Collectorate, Puri for the project "Development of Heritage Security Corridor around Shree Jagannath Temple, Puri" out of ABADHA Scheme for a period of one year or till completion of Land Acquisition process in Puri under the ABADHA Scheme whichever is earlier with same terms and conditions.

And whereas, Government vide order No. 34632 dated 13.10.2022 published in EOG Vide No. 3032 dated 20.10.2022 had been pleased to extend the time period for functioning of Special Land Acquisition cell, Collectorate, Puri for different projects in Puri under ABADHA Scheme for a period of one year or till completion of Land Acquisition process in Puri under the ABADHA Scheme whichever is earlier with same terms and conditions.

And whereas, the Collector, Puri has submitted the proposal regarding extension of time period for a further period of two years towards functioning of Special Land Acquisition Cell, Collectorate, Puri for the Land Acquisition process of different Projects under the ABADHA Scheme in Puri along with land acquisition work for the Project "Shree Jagannath International Airport, Puri".

Now, therefore Government have been pleased to extend the time period for functioning of Special Land Acquisition Cell, Collectorate, Puri for a further period of two years or till completion of Land Acquisition process of different Projects in Puri under the ABADHA Scheme along with land acquisition work for the Project "Shree Jagannath International Airport, Puri whichever is earlier with same terms and conditions as enumerated in Revenue & DM Department Order 38690 dated 05.12.2019. Letter No. 38664 dated 05.12.2019 & Letter No. 14239 dated 31.03.2020.
