No. PT1-RDM-CON-CASEHC-0029-2023- 1139 **/R&DM,** Pursuant to the order dated 06.08.2021 passed in WPC(OAC) No.913 of 2017 filed by D. Maleswar Patra, decision was taken to allow all the reverted ORS Gr.B officers appointed against the year 2011 & 2012 to continue in the said post against their original recruitment year. Accordingly, Sultan Khan appointed to ORS Gr.B against the recruitment year 2011 and subsequently reverted to his parent post vide Revenue & D.M Department Notification No. 35083/RDM dated 11.11.2016 was allowed to continue in ORS Gr.B against the year 2011.

Consequent upon such continuance in ORS Gr.B against the year 2011 and in compliance to the order dated 14.09.2022 of the Hon'ble High Court passed in WPC(OAC) No.4264 of 2016, the case of Sultan Khan for promotion to OAS Gr.A(JB) was placed before the Review Selection Board held on 12.12.2023 .

In consideration of the recommendation of the Review Selection Board, Sultan Khan, OAS Gr.A(JB), Survey Commissioner of WAKFs, Odisha who was earlier promoted to OAS Gr.A(JB) vide Revenue & D.M Department Notification No.33792/R&DM dated 01.10.2022, is hereby promoted to OAS Gr.A(JB) notionally w.e.f. 13.02.2020, i.e. the date his junior, Sri Nihar Ranjan Mallick got such promotion.

The Notification No.33792/R&DM dated 01.10.2022 issued earlier is modified to this extent.
