No. PT1-RDM-CON-CASEHC-0029-2023- 911 /R&DM, Pursuant to the instructions of G.A. & P.G. Department issued vide Letter No. 12821/SCS dated 04.05.2018 read with Letter No.29436/SCS dated 29.12.2020, the date of appointment of Sri Aswini Kumar Mohapatra in ORS Gr.B was treated as 04.03.2016, i.e. the date of appointment of ORS direct recruits of 2011.

The Notification No.33792/R&DM dated 01.10.2022 issued earlier is modified to this extent.




