No. PT1-RDM-CON-CASEHC-0029-2023- **948** /R&DM, Pursuant to the order dtd.25.08.2016 of the Hon'ble Tribunal passed in O.A No.367(C)/2013, Sri Karunakar Dhinda was reallocated against the recruitment year 2011 in ORS Gr.B vide Revenue & D.M Department Notification No.42627/R&DM, dated 17.11.2018.
