S.R.O.No.63/2024— The following draft of certain rules further to amend the Odisha Government Land Settlement Rules, 1983 which the State Government propose to make in exercise of the powers conferred by Section 8-A of the Odisha Government Land Settlement Act, 1962 (Odisha Act 33 of 1962), is hereby published as required under sub-section (1) of the said section for the information of all persons likely to be affected thereby and notice is hereby given that the said draft will be taken into consideration on or after expiry of a period of thirty days from the date of publication of this Notification in the *Odisha Gazette*.

Any Objection or suggestion which may be received from any persons with respect to the said draft before expiry of the period specified above will be considered by the State Government.

- Short title and commencement. (1) These rules may be called the Odisha Government Land Settlement (Amendment) Rules, 2024.
 - (2) They shall come into force on the date of their publication in the Odisha Gazette.
- In the Odisha Government Land Settlement Rules, 1983, in the Schedule VII, –
 - (i) in clause 2, in sub-clause (8), for the word "though", the word "through" shall be substituted.

- (ii) in clause 5, for the words "at the rate of ten per centum of the prevailing market value of the land", the words and numerals "at the rate of three per centum of the valuation of land as per the guidelines prescribed under the Odisha Stamp Rules, 1952 for a Gharabari Kisam of land adjacent to or in the vicinity" shall be substituted.
