**RESOLUTION**

**Subject: Restructuring of the Odisha District Revenue Service**

No.RDM-NGEB-PGOT-0048-2023. 8154 /R&DM., Due to implementation of ORTPS Act for timely public service delivery and 5T charter, the work of the Amins and ARIs has increased manifold and their job responsibility has increased.
