The licensed Stamp Vendors are getting about 1% to 4% commission in selling of non-judicial stamp papers ranging from Rs.1 to Rs.25000/- denomination to Stamp paper. Due to introduction payment of stamp duty through e- stamping in the year, 2016, the selling of non-judicial stamp and stamped papers decreased substantially which directly affects the livelihood Licensed Stamp Vendors. The licensed stamp vendors engaged as Authorized Collection Centre (ACC) under e-Stamping system were getting commission of 0.15% by Stockholding Corporation of India Ltd(SCIL) out of its commission of 0.65% on issue of e-stamping certification on collection of stamp duty. The Odisha Stamp Vendors' Mahasangha was ventilating their grievances to the higher authorities for enhancement of commission on e-stamp certificates due to decrease of selling non-judicial stamp papers.

- 2. Odisha Stamp Vendors' Mahasangha had also approached Hon'ble High Court in WPC No. 33684/2022 praying for fixation of e-stamp commission and Hon'ble Court disposed of the Writ petition No. 33684/2022 without expressing any opinion on the merits of the case with a direction to the OP No. 1 ( Principal Secretary to Government, Revenue Department ) to take decision on the proposal submitted by the Inspector General of Registration on 15th September, 2020 with regard to fixation of commission of stamp vendors and inclusion of Licensed Stamp Vendors as Authorized Collection Centre (s) under the e-stamp system.
- 3. After, series of meeting with all stake holders and approval it is decided that the licensed stamp vendors engaged as Authorized Collection Centre (ACC) under e-Stamping is to be provided commission of 0.85% by the State Government and 0.15% by Stockholding Corporation of India Ltd(SCIL) out of its commission of 0.65% so that the total commission to the licensed stamp vendors becomes 1%. as adopted by Government of Uttarakhanda.
- 4. Further, Stock Holding Corporation ( Central Record Keeping Agency (CRA)) shall submit single invoice for the month to the Inspector General of Registration with breakup of stockholding commission ( 0.65%) and proposed ( 0.85%) additional commission to be paid by Government to the stamp vendors engaged as ACC ( Authorised Collection Centre). After receipt of the total commission amount from the Inspector General of Registration, Odisha, Stock Holding Corporation will disburse the additional commission ( 0.85%) and Stockholding share of commission (0.15%) to the stamp vendors engaged as ACC ( Authorised Collection Centre) at one time to the registered Bank Account basing on collection of stamp duty for the month to the each stamp vendor.



This order will come in to force with immediate effect.
