**NOTIFICATION**

No. 36336—GE.—(GL)-S-36/93-R.—Whereas the draft of the Orissa Government Land Settlement (Amendment) Rules, 1993 was published as required by sub-section (1) of Section 8-A of the Orissa Government Land Settlement Act, 1962 (Orissa Act 33 of 1962), in an extraordinary issue of the *Orissa Gazette* No. 806, dated the 14th June 1993 being S. R. O. No. 445/93 under the notification of the Government of Orissa in the Revenue and Excise Department No. 24239-GE (GL) S-36/93-R., dated the 27th May 1993 inviting objections and suggestions from all persons likely to be affected thereby before the expiry of the period of thirty days from the date of such publication;

And whereas no objection or suggestion has been received from any person with respect to said draft

Now, therefore, in exercise of the powers conferred by Section 8-A of the Orissa Government Land Settlement Act, 1962 (Orissa Act 33 of 1962), the State Government do hereby make the following rules further to amend the Orissa Government Land Settlement Rules, 1983, namely:—

1. (1) These rules may be called the Orissa Government Land Settlement (Amendment) Rules, 1993
- (2) They shall come into force on the date of their publication, in the *Orissa Gazette*
2. In the Orissa Government Land Settlement Rules, 1983, in Schedule-IV (1) in rule 1,—
  - (i) in clause (k) for the words “Town Planner”, the words “Director, Town Planning, Orissa” shall be substituted; and
  - (ii) clause (d) shall be omitted ; and
  - (2) in rule 2, for the words “Town Planner”, the words “Director, Town Planning, Orissa” shall be substituted; and
  - (3) in rule 3,—
    - (i) in clause (b) for the existing item (ii), the following item shall be substituted, namely:—
    - “(iii) Director, Town Planning, Orissa” ; (ii) in clause (g), for the words “Rourkela Civil Township” and “Rourkela Township” wherever they occur, the words “Rourkela Civil Township or Rourkela Steel Township” shall be substituted; (iii) items (i) and (ii) appearing below clause (b), shall be renumbered as clauses (i) and (j) respectively and clause (j) as so renumbered, the following proviso shall be added, namely;

“Provided that the Government may exempt or reduce the premium payable in any case or class of cases for settlement of land”.
