NOTIFICATION

No. RDM-LRGEA-STATUT-0001-2023 - 22078

Whereas, under item (i) of the proviso to clause 1 of the Schedule V-A of the Odisha Government Land Settlement Rules, 1983, for settlement of land, applications were required to be submitted within a period of six months from the date of publication of the Odisha Government Land Settlement (Amendment) Rules, 2022; or within such further period as the Government may by notification, specify for such settlement of land;

And, whereas, the period of limitation was extended from time to time and the last such extension has been made in the notification of the Government of Odisha in the Revenue & Disaster Management Department No. 13135-RDM-LRGEA-STATUT-0001/2023/R&DM, dated the 13th April, 2023 published in the Extra-ordinary issue of the Odisha Gazette No. 803, dated the 15th April, 2023;

And, whereas, the period of limitation so extended have expired on the 31st October, 2023;


And, whereas, it has come to notice that a number of applicants are still awaiting to apply for settlement of the land of the categories mentioned in sub-clauses (a) and (b) of clause 1 of the Schedule V-A of the Odisha Government Land Settlement Rules, 1983;

And, whereas, unless the time limit is extended, a number of applicants shall be debarred from getting such land settled with heritable and transferable rights;

And, whereas, the State Government are satisfied that there exists sufficient reasons for extending the said period of limitation;

Now, therefore, in exercise of the powers conferred by item (i) of the proviso to clause 1 of the Schedule V-A of the Odisha Government Land Settlement Rules, 1983, the State Government do hereby further extend the said period upto the 31st March, 2025.
