No. RDM-CON-PM-0064-2019- **24585** /R&DM, Shri Anushrav Gantayat who has come out successful in Odisha Civil Services Examination, 2017 conducted by the Odisha Public Service Commission pursuant to the judgment dated 19.12.2023 passed by the Hon'ble High Court of Orissa in W.P.(C) No.21215 of 2019, is hereby appointed to Odisha Administrative Service, Group-A (Junior Branch) in Cell-1, Level-12 of the Pay Matrix under Odisha Revised Scale of Pay Rules, 2017 as per Odisha Administrative Services (Method of Recruitment and Conditions of Service) Rules, 2011 with effect from 24.06.2019, i.e. the date of joining of Shri Abhisek Dash, junior to Shri Gantayat on the basis of the Select List furnished by G.A. & P.G. Department vide their Letter No. 15579/SCS dated 04.06.2019 read with their Letter No. 13359/SCS dated 02.05.2024 against the supernumerary post created in OAS Gr.A (JB) vide Revenue & DM Department Letter No.18113/RDM dated 10.06.2024.

The said supernumerary post would remain in existence till the actual date of joining of Shri Gantayat in the OAS cadre.

The appointment of Shri Gantayat is subject to verification of character and antecedents. On receipt of adverse report on character and antecedents, his services shall be terminated forthwith in accordance with the provisions laid down in sub-clause (ii) of clause (h) of Explanation under Rule-13 of the Odisha Civil Services (Classification, Control and Appeal) Rules, 1962, reinforced in G. A. Department Resolution No.34438/Gen., dated 20.11.1999.

On being appointed to OAS Group-A (JB), he is hereby posted as Training Reserve Officer, Puri. He shall be on probation till confirmation in service.

The pay of Shri Gantayat in OAS Gr.A(JB) shall be fixed notionally w.e.f. 24.06.2019 and with actual financial benefit from the date he joins in the said post. Sanction of subsequent increments due after actual joining in the cadre shall be regulated in terms of Rule-8 of the Odisha Administrative Service Group-A (Junior Branch) (Probation and Departmental Examination) Rules, 2014.

He is instructed to join in his place of posting within 30 days from the date of issue of this appointment order failing which the offer of appointment will lapse automatically.

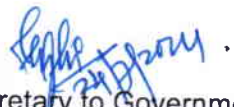
