No. RDM-CON-MISC-0081-2017 **30773** /R&DM, Dillip Kumar Sahu, Asst. Teacher and Madhab Behera, Asst. Teacher both working under BEO, Phulbani were appointed to ORS Group-B by way of Selection for the year 2018 and posted as Training Reserve Officer in Kandhamal district vide Revenue & D.M Department Notification No.15579/R&DM dtd.11.05.2020. Accordingly, the concerned controlling authorities were requested thereunder to relieve them in order to join as TRO, Kandhamal in ORS Gr.-B. But, instead of relieving them, Joint Director (GS), Secondary Education, O/o the Director, Secondary Education, Odisha vide Letter No.10971 dtd.13.05.2020 intimated Revenue & D.M Department that the name of Dillip Kumar Sahu, Asst. Teacher and Madhab Behera, Asst. Teacher were not recommended by the DEO, Kandhamal for their selection to ORS Group-B.

Consequently, the Collector, Kandhamal was requested vide Revenue & D.M Department Letter No.18732 dtd.05.06.2020 to lodge an FIR against the above two Asst. Teachers for act of forgery and unethical way to get their name being selected to ORS cadre. Accordingly, an FIR has been lodged against them in Phulbani Town PS case No. 84 dtd.18.6.2020 u/s 420/468/471/34 of IPC which is under investigation.

In view of the above facts, Government after careful consideration, have been pleased to cancel the appointment of Dillip Kumar Sahu, Asst. Teacher and Madhab Behera, Asst. Teacher to ORS Group-B issued vide Revenue & D.M Department Notification No.15579/R&DM dtd.11.05.2020.
