Sub: Standardization of Services and Management of Special Circuit Houses, Circuit Houses and Court Guest House Gopalpur-on Sea of the State.

Madam/Sir,

I am directed to invite a reference on the subject cited above and to say that the process for privatization of Comprehensive Facilities Management Services (CFMS) in respect of some selected Special Circuit Houses, Circuit Houses of the State and Court Guest House, Gopalpur-on Sea of Ganjam district have already been started at the appropriate level.

In order to delivery better services to the Guests henceforth, the Government after careful consideration have standardized the cost and quality of foods to be provided to the Guests in all Special Circuit Houses/Circuit Houses of the State and in Court Guest House-Gopalpur-on-sea.

The standardized menu and revised cost thereof for different items are as follows:- :-

10.	Any item / items other than those specified above to be required by the Guests	The same shall be procured from the Local Market subject to availability by the Manager/Asst. Manager/Nazir/ Asst. Nazir /CFMS as the case may be and to be supplied on cost to cost basis.	

The revision of the above rate will come into immediate effect.
