Whereas the preliminary notification under section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 was issued by Government for acquisition of private land measuring an area of Ac. 11.54 in Village- Hotapur, P.S.- Baisinga No.165, Tahasil- Betnoti of Mayurbhanj district for construction of Haripur Distributary, Bartana Sub-Minor & Baidipur Sub-Minor under Subarnarekha Irrigation Project vide Revenue and DM Department Notification No. 30210 dated 12.09.2022 which was published in the Extraordinary issue of Odisha Gazette on dated 11.11.2022 and Declaration under section 19(1) of the Act in respect of the above schedule of land has not been issued till date ;and

Whereas, while sub-section (7) of section 19 of the Act provides that where no declaration is made under subsection (1) of section 19 within twelve months from the date of preliminary notification, such notification shall be deemed to have been rescinded and the second proviso to subsection (7) of section 19 contains an enabling provision which provides that the appropriate Government shall have the power to extend the period of twelve months, if in its opinion circumstances exist justifying the same; and

Whereas, on the basis of the justification offered by the Water Resources Department to extend the period of twelve months, the appropriate Government is of the opinion that circumstances existed for the inadvertent delay;

and now, therefore, in exercise of the powers conferred by second proviso to sub-section (7) of section 19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (30 of 2013), the State Government do hereby decide to extend the period of twelve months up to 10th November 2024 for issue of Declaration under section 19(1) of the said Act.
