NOTIFICATION

No. RDM-LAA-MBJ-0013-2022- 20164 /R&DM, Dated 28 JUN 2024

Whereas the preliminary notification under section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 was issued by Government for acquisition of private land measuring an area of Ac. 17.87 in Village- Nachhipuria, P.S.- Baisinga No.133, Tahasil- Betnoti , Dist- Mayurbhanj for construction of Raghunathpur Distributary, Nuhurda Sub-Minor No.2 and Durgapur Sub-Minor under Subarnarekha Irrigation Project vide Revenue and DM Department Notification No.11022 dated 06.04.2022 which was published in the Extraordinary issue of Odisha Gazette on dated 24.05.2022 and Notification was also issued for withdrawal of an area of Ac.0.88 out of the total notified area of Ac.17.87 vide No. 13539 dated 18.04.2023 and declaration under section 19(1) of the Act has not been issued till date; and

Whereas, while sub-section (7) of section 19 of the Act provides that where no declaration is made under subsection (1) of section 19 within twelve months from the date of preliminary notification, then such notification shall be deemed to have been rescinded, the second proviso to subsection (7) of section 19 provides that the appropriate Government shall have the power to extend the period of twelve months, if in its opinion circumstances exist justifying the same; and

Whereas, basing on the justification given by the Water Resources Department to extend the period of twelve months, the appropriate Government is of the opinion that circumstances existed for the inadvertent delay;

And now, therefore, in exercise of the powers conferred by second proviso to sub-section (7) of section 19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (30 of 2013), the State Government do hereby decide to extend the period of twelve months from the date of Preliminary Notification u/s 11(1) of the RFLTLAR&R Act, 2013 up to **4th July 2024** for issue of Declaration under section 19(1) of the said Act.

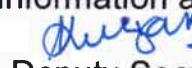
