NOTIFICATION

NO. RDM-LAC-KNJ-0004-2024/ 3/77 R&DM, DATED 29 JAN 2025

Whereas the preliminary notification under section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 was issued by the appropriate Government for the acquisition of private land measuring an area of Ac. 0.656 in the village—**Palasa(Ka)**, P.S.- Joda, under Barbil Tahasil of Keonjhar District, vide Collectorate, Keonjhar Notification No. 674 dated 21.12.2020 for Improvement to Bamebari-Palasa Guruda - Koiria Road from 0/0Km to 10/0 under DMF, which was published in the Extraordinary issue of Odisha Gazette No. 671 dated 19.03.2024 and Declaration under Section 19(1) of the Act in respect of the above schedule of land has not been issued till date;

And whereas, as per sub-section (7) of Section- 19 of the Act, where no declaration is made under sub-section (1) of Section- 19 within twelve months from the date of preliminary notification, then such notification shall be deemed to have been rescinded and the second proviso to sub-section (7) of Section- 19 provides that the appropriate Government shall have the power to extend the period of twelve months, if in its opinion circumstances exist justifying the same;

And whereas, the Works Department has requested with reasons to extend the period of twelve months and the appropriate Government is of the opinion that circumstances existed for the inadvertent delay;

Now, therefore, in the exercise of the powers conferred by the second proviso to sub-section (7) of section 19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (30 of 2013), the State Government do hereby decided to extend the period of validity up to **31.03.2025** for the issue of Declaration under Section- 19(1) of the said Act.

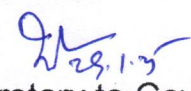
