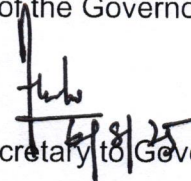
NOTIFICATION

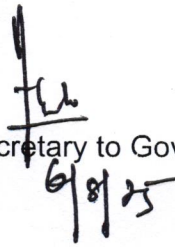
