**NOTIFICATION**

Bhubaneswar, dated the **04 OCT 2025**

No. RDM-Reg-REGN-0048-2020 37417 /R&DM, In exercise of the powers conferred by Sub-Section (1) of the Section-5 and Sub-Section (1) of the Section-7 of the Registration Act, 1908 (16 of 1908) and in partial modification of the Notification of the Government of Odisha in erstwhile Revenue & Excise Department No.166/62-17522 dated 20.03.1963 the State Government do hereby direct that the villages as specified in the Schedule below, which have hitherto been included in the local limits of Registration Sub-District of **Nuapada**, as the case may be, shall with effect from **4<sup>th</sup> October 2025**, cease to have been so included and from the said date, the said villages shall form a part of the Registration Sub-District of **Komna** with Headquarter at **Komna** in the Registration District **Nuapada**.

In exercise of the powers conferred by Section-6 of the Registration Act, 1908 (16 of 1908), the State Government do hereby appoint the Tahasildar, Komna as ex-officio Sub-Registrar of the Registration Office, **Komna** with effect from the date as specified above.
