Bhubaneswar, dated the **25 OCT 2025**

No. RDM-Reg-REGN-0048-2020 39998 /R&DM, In exercise of the powers conferred by Sub-Section (1) of the Section-5 and Sub-Section (1) of the Section-7 of the Registration Act, 1908 (16 of 1908) and in partial modification of the Notification of the Government of Odisha in erstwhile Revenue & Excise Department No. 13960/R dated 04.03.1963, the State Government do hereby direct that the villages as specified in the Schedule below, which have hither to been included in the local limits of Registration Sub-District of **Koraput**, shall with effect from **1st November 2025** cease to have been so included and from the said date, the said villages shall form a part of the Registration Sub-District of **Bandhugaon** with Headquarter at **Bandhugaon** in the Registration District **Koraput**.

2. In exercise of the powers conferred by Section-6 of the Registration Act, 1908 (16 of 1908), the State Government do hereby appoint the **Tahasildar, Bandhugaon** as ex-officio Sub-Registrar of the Registration Office, **Bandhugaon** with effect from the date as specified above.


