**NOTIFICATION**

Bhubaneswar, dated the **25 OCT 2025**

No.RDM-Reg-REGN-0048-2020 40138 /R&DM, In exercise of the powers conferred by Sub-Section (1) of the Section-5 and Sub-Section (1) of the Section-7 of the Registration Act, 1908 (16 of 1908) and in partial modification of the Notification of the Government of Odisha in erstwhile Revenue & Excise Department No.25656 dated 24.04.1964 and No.28955 dated 01.05.1965, the State Government do hereby direct that the villages as specified in the Schedule below, which have hitherto been included in the local limits of Registration Sub-District of **Mayurbhanj**, shall with effect from **1st November 2025** cease to have been so included and from the said date, the said villages shall form a part of Registration Sub-District of **Shamakhunta** with Headquarter at **Shamakhunta** in the Registration District, **Mayurbhanj**.

2. In exercise of the powers conferred by Section-6 of the Registration Act, 1908 (16 of 1908), the State Government do hereby appoint the **Tahasildar, Shamakhunta** as ex-officio Sub-Registrar of the registration Office, **Shamakhunta** with effect from the date as specified above.






