
No. RDM-Reg-POLICY-0001-2025- 47476 /R&D.M., In exercise of the powers conferred by section 78 read with section 79 of the Registration Act, 1908 (Act 16 of 1908), the State Government do hereby make the following amendment to the existing table of fees payable for the purpose of section 78 of the said Act within the State of Odisha, namely: --

Amendment

In Article-A, in Part-I, in clause-1, after sub-clause 1-C of the Table of Fees, the following sub-clause shall be inserted, namely: --

"1-D. Fees for registration of the deed of conveyance executed by the Promoter involving transfer of common areas and facilities in favour of the association of allottees to which the Odisha Apartment (Ownership and Management) Act, 2023 apply, shall be a fixed fee of Rs. 20,000/-".
