No. RDM-GOEA-PM-0403-2025- 49094 /R&DM, In pursuance of Odisha Administrative Services (Method of Recruitment and Conditions of Service) Rules, 2011, the State Government do hereby appoint the following 30 (Thirty) candidates who have come out successful in Odisha Civil Services Examination, 2023 conducted by the Odisha Public Service Commission to Odisha Administrative Service, Group-A (Junior Branch) in Cell-1, Level-12 of the Pay Matrix under Odisha Revised Scale of Pay Rules, 2017.

They shall be on probation for a minimum period of 2 (two) years from the date of their joining in the post subject to fulfilment of conditions laid down under the rules and their appointment is subject to verification of character and antecedent and verification of original certificates in cases where it has not been done. On receipt of the adverse report on character and antecedent, his/ her services shall be terminated forthwith in accordance with the provisions laid down in sub-clause (ii) of clause (h) of Explanation under Rule-13 of the Orissa Civil Services (Classification, Control and Appeal) Rules, 1962, reinforced in G.A. Department Resolution No. 34438/Gen. dated 20.11.1999.

On being appointed to the OAS Group-A (JB), the candidates are hereby posted as Training Reserve Officers in the districts mentioned against each.

The candidates are instructed to join in the respective District Offices (Office of the Collector & District Magistrate) within 30 days from the date of issue of this appointment order failing which the offer of appointment will lapse automatically.
