No. RDM-GOEA-PM-0066-2024- 8355 /R&DM, Sri Prabhudatta Sahani who has come out successful in the Odisha Civil Services Examination, 2022 conducted by the Odisha Public Service Commission pursuant to orders passed by the Hon'ble High Court of Orissa in W.P.(C) No. 4191 of 2025 read with order No. 02 dated 01.08.2025 in W.P.(C) No. 15215 of 2025 is hereby appointed to Odisha Administrative Service, Group-A (Junior Branch) in Cell-1, Level-12 of the Pay Matrix under Odisha Revised Scale of Pay Rules, 2017 as per the Odisha Administrative Services (Method of Recruitment and Conditions of Service) Rules, 2011 with effect from 27.12.2024 i.e. the date similarly placed person (s) in the select/ merit list were appointed as per this Department Notification No. 45843/R&DM dated 27.12.2024 against supernumerary post created in OAS Group-A (JB) vide Revenue & D.M. Department Letter No. 3841/R&DM dated 28.01.2026.

The supernumerary post so created to accommodate Sri Sahani in the OAS cadre shall stand abolished on the date on which a regular vacancy arises.

The inter-se-seniority of Sri Sahani shall be fixed in the Gradation List of the OAS Group-A (JB) Officers, below Ranjeeta Baxla (OPSC Sl. No. 551) and above Biraj Lothe Xalxo (OPSC Sl. No. 553) of OCSE-2022 Batch. His residency period for promotion shall be counted from the date of joining of his junior i.e. Biraj Lothe Xalxo.

The appointment of Sri Sahani is subject to verification of character & antecedent. On receipt of adverse report on character & antecedent, his services shall be terminated forthwith in accordance with the provisions laid down in the sub-clause (ii) of clause (h) of Explanation under rule-13 of the Odisha Civil Services (Classification, Control and Appeal) Rules, 1962 reinforced in G.A. Department Resolution No. 34438/ Gen. dated 20.11.1999.

On being appointed to the OAS Group-A (JB), he is hereby posted as the Training Reserve Officer, Cuttack. He shall be on probation till his confirmation in service.

The pay of Sri Sahani shall be fixed on notional basis in OAS Group-A (JB) Scale with effect from the date of joining of his junior, Sri Biraj Lothe Xalxo i.e. 24.01.2025 with actual financial benefits from the date he joins in the said post. Sanction of the subsequent increments due after actual joining in the cadre shall be regulated in terms of the Rule-8 of the Odisha Administrative Service Group-A (Junior Branch) (Probation and Departmental Examination) Rules, 2014.

He is instructed to join in his place of posting within 30 days from the date of issue of this appointment order failing which the offer of appointment will lapse automatically.
